## Inspection Finding:

1) Quantity check

During inspection, 80pcs pipes were found on site, all pipes were painted with black coating from outside. Tube ends were machined with bevels.




2) <u>Visual quality inspection randomly, (sample size: ANSI/ASQ, Z1.4-2008, L-II, 13 pieces totally)</u>

Remark: 1. As the requirement from the ASTM A999 part 12.1.1, for the pipe which length is more than 7.3m, the tolerance of the length should be discussed by purchaser and manufacturer.

2. As the requirement from the ASTM A999 part 16.2, the straightness shall be measured by straight ruler with the length of 3m. The manufacturer didn't have this equipment, the inspector can not check it onsite.

5) <u>Lab testing randomly in SGS lab, including chemical analysis: C,Si,Mn,P,S,Cr,Mo, mechanical properties: tensile test, flatten test for ASTM A335</u>, sample size 1pc

The samples have been sent to SGS lab for testing.



6) <u>Witness hydrostatic testing in manufactory's lab</u>, (sample size: ANSI/ASQ, Z1.4-2008, L-II, 13 pieces totally)

Since the limited condition of the inspection site, the hydrostatic test can't be performed.
